- **NARIC Kosova center has been established with the decision of the Minister of Education, Science and Technology of Kosovo in November 2008 (Decision number 331/01-B).**

**The aim establishing the center was:**

- Simplify recognition procedures ;
- Education systems in both foreign countries and in the own country;
- Opportunities for studying abroad, including information on loans and scholarships, as well as advice on practical questions related to mobility and equivalence.



## **Administrative Instruction for Recognition Number: 08 / 2010**

**Principles and procedures in Recognition for Higher Education diplomas awarded outside Kosovo.**

- **Recognition of the degrees in terms of study continuation is in the competence of the University.**

## **General principles of the evaluation and recognition**

- **The right to apply for recognition have Kosovo citizens**
- **The right to apply for recognition have also foreign citizens if they show legal interest.**  
(Legal Interest is proved by submitting job contract, marriage certificate, trade representation etc.)
- **The procedures and criteria implemented in Kosovo for recognition and evaluation of foreign qualification will be transparent, coherent and reliable, in accordance with provisions and relevant European standards in the field of recognition and evaluation of qualifications.**



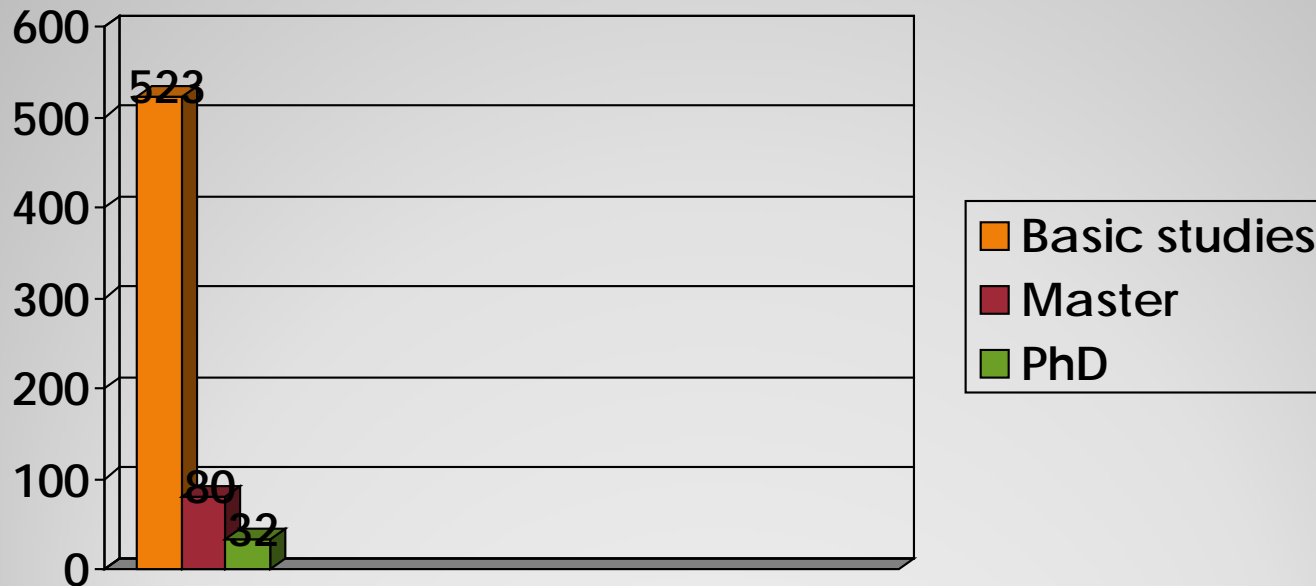


## **Challenge – rationalization**

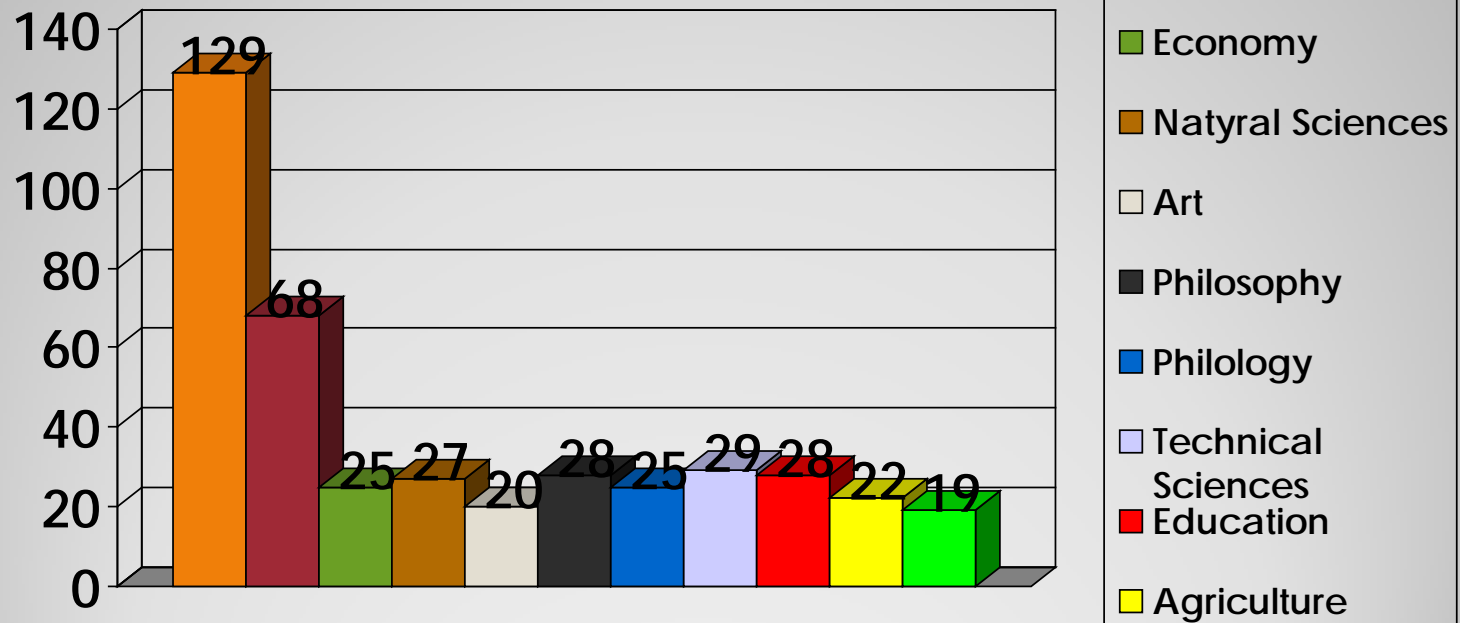
**In cases when a degree, for which the recognition is required, it is not in accordance with any study programme offered in Kosovo, then as a target subject will be the recognition of foreign qualification without referring the field of study in the nation. The educational achievement level will be expressed in terms of ISCED and EQF-until the National Qualification Framework will take place.**

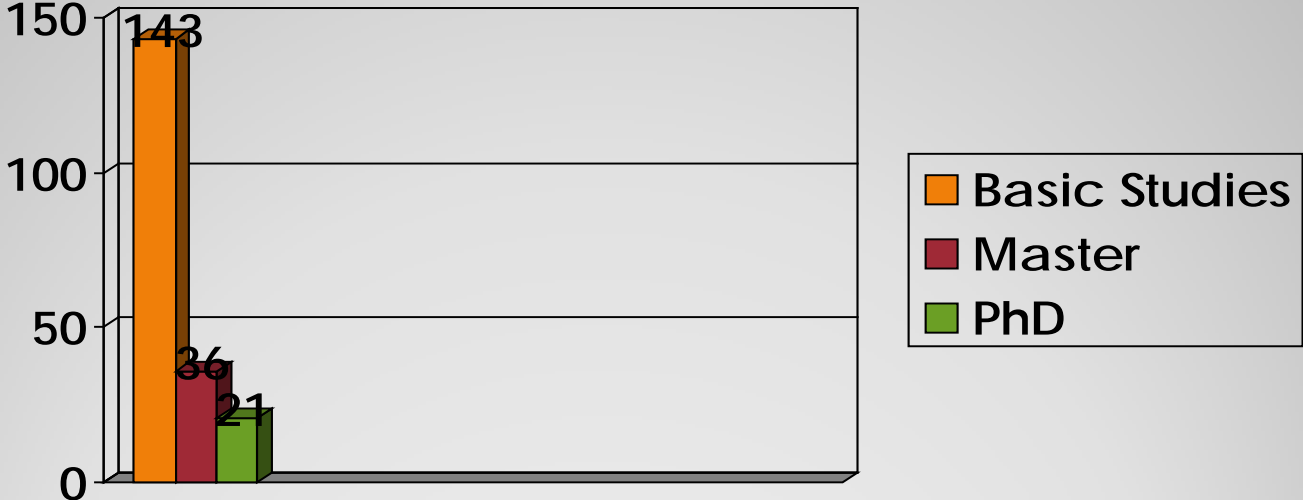


## Statistics based on the field of study 2008/2009

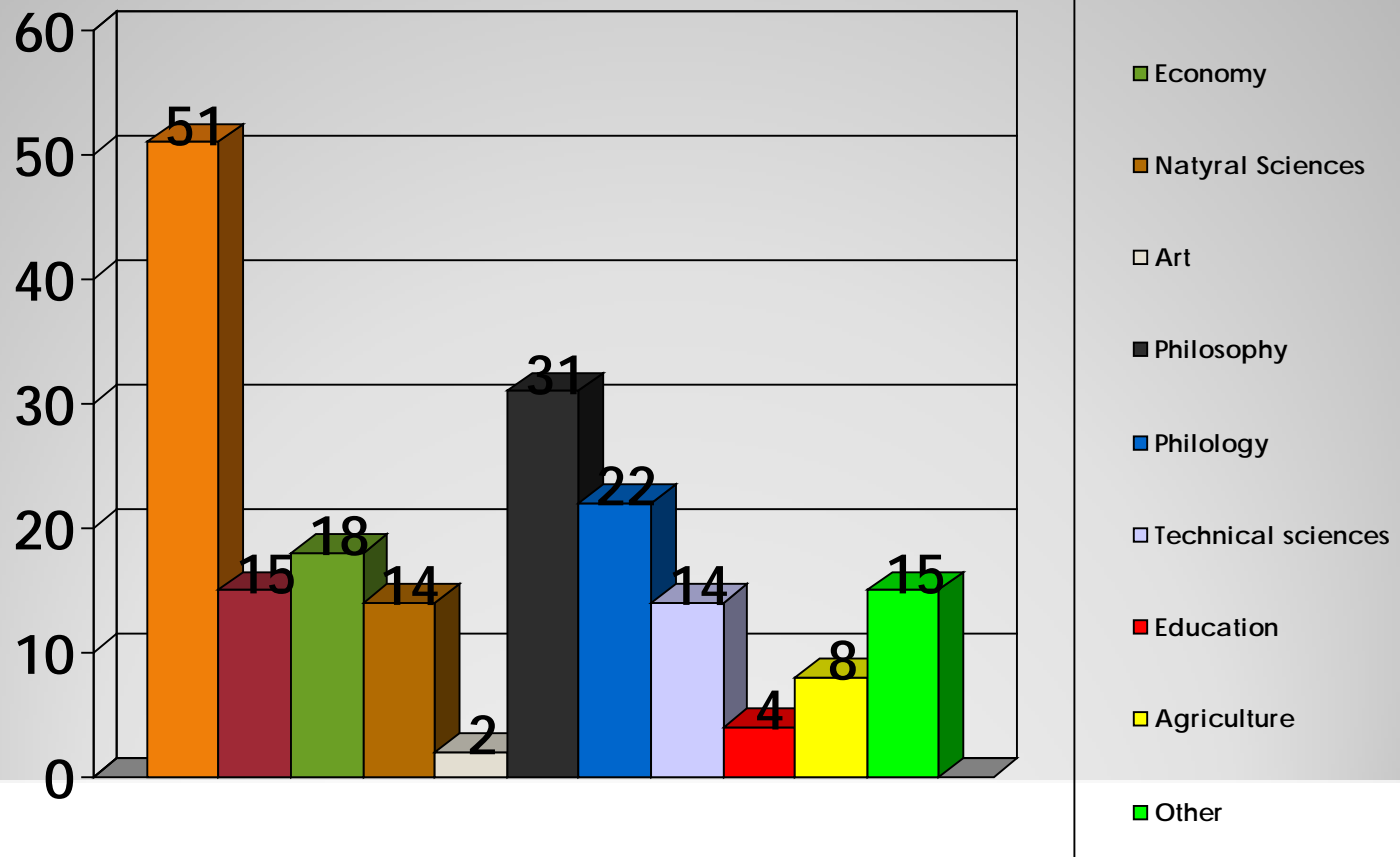




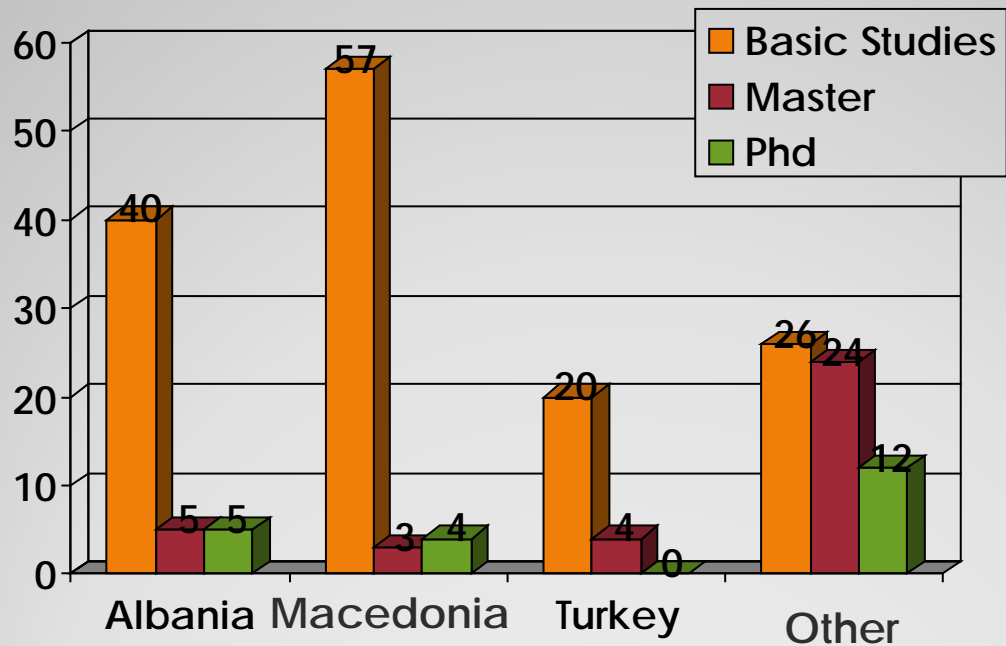

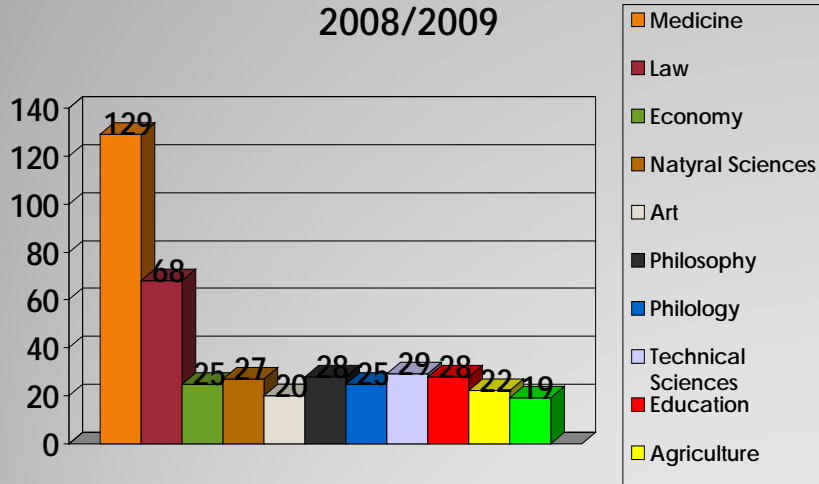

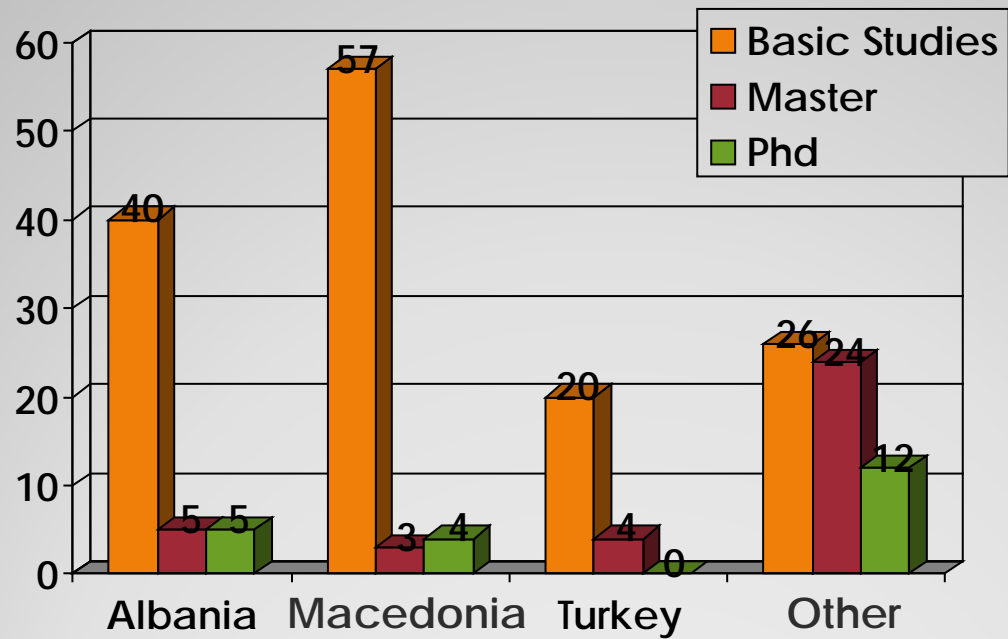
